ORDINANCE 2012-03

AN ORDINANCE AMENDING CHAPTER 121.03, ARTICLE XII, SUBSECTION (1)(d) OF THE MANTUA VILLAGE CODIFIED ORDINANCES CONCERNING THE APPOINTMENT OF AN ALTERNATE REPRESENTATIVE TO THE MANTUA-SHALERSVILLE FIRE BOARD, AND DECLARING AN EMERGENCY.

WHEREAS, the Finance Committee has recommended that the alternate representative to the Mantua-Shalersville Fire Board need not be the President Pro-Tempore of Village Council; and

WHEREAS, this Council now wishes to address this recommendation by amending Chapter 121.03, Article XII, subsection (1)(d) of the Village of Mantua Codified Ordinances.

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Mantua, two-thirds or more of the members elected thereto concurring that:

SECTION 1. Existing subsection (1)(d) of Article XII, Chapter 121.03 of the Codified Ordinances of the Village of Mantua is hereby repealed.

SECTION 2. Chapter 121.03, Article XII, subsection (1)(d) of the Village of Mantua Codified Ordinances is hereby enacted as follows:

MSFD Fire District Board member appointed by Council President ProTempore, who shall attend all Fire Board meetings and submit all approved minutes, and agendas, to the Clerk of Council for the Council meeting packets. An alternate representative shall also be appointed in the same manner as the primary Board Member, who shall perform the aforementioned duties at any time the appointed Board Member is absent or unavailable.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance is hereby declared to be an emergency measure, in order to appoint an alternate representative to the Mantua-Shalersville Fire District Board at the earliest time possible, and shall take effect immediately upon the affirmative vote of two-thirds of the members of the Mantua Village Council, and to further ensure the health, safety and morals of the Village of Mantua.
