**RESOLUTION 2014-38**

**A RESOLUTION INSTITUTING A ONE-TIME SEWER CHARGE CREDIT FOR WATER USED TO FILL SWIMMING POOLS BETWEEN APRIL 1 AND AUGUST 19, 2014, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Service Committee has recommended that a one-time sewer charge credit be granted to customers who have used water from the Village water system to fill swimming pools during the spring and summer of 2014.

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Mantua, two-thirds or more of the members elected thereto concurring, that:

**SECTION 1:** Village of Mantua Water and Sewer customers who have used water supplied by the Village water system to fill a swimming pool between April 1 and August 19, 2014 may apply for a credit on their corresponding sewer charges no later than September 12, 2014.

**SECTION 2:** Application shall be made on a form prescribed by the Village Administrator, and shall include certification by the customer that the water used shall not enter the Village sanitary sewer system, and any additional conditions prescribed by the Village Administrator.

**SECTION 3:** A credit shall only be granted upon review and approval by the Village Administrator.

**SECTION 4:** The credit will be calculated by averaging the volume of water consumed based on the six (6) lowest of the customer's previous eight (8) quarterly water and sewer billings. That average will then be subtracted from the water consumption indicated by the customer's highest 2014 quarterly billing. The credit awarded will be the difference between the high consumption and the average low consumption.

**SECTION 5:** Any sewer charge credit approved pursuant to this Resolution shall be used to offset current and/or future Village Sewer charges until such time as the credit is exhausted. No refunds shall be given.

**SECTION 6:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 7:** This Resolution is hereby declared an emergency measure, in order to permit the granting of a sewer charge credit to qualifying customers at the earliest possible time, and shall become immediately effective upon passage by at least two-thirds of the members elected to the Mantua Village Council.
