**ORDINANCE 2017-45**

**AN ORDINANCE AMENDING SECTION 305.07(a) OF THE CODIFIED ORDINANCES OF THE VILLAGE OF MANTUA, IN ORDER TO MAKE SECOND STREET ONE-WAY SOUTHBOUND.**

**WHEREAS**, it has been recommended by the Service Committee that Second Street be made a one-way street southbound, requiring amendment of Section 305.07(a) of the Codified Ordinances of the Village of Mantua.

**NOW THEREFORE**, be it Ordained by the Council of the Village of Mantua, Portage County, Ohio, a majority or more of the members elected thereto concurring, that:

**SECTION 1:** Existing Section 305.07(a) of the Village of Mantua Codified Ordinances is hereby repealed.

**SECTION 2:** Section 305.07(a) of the Village of Mantua Codified Ordinances is hereby enacted as follows:

**305.07 ONE-WAY STREETS.**

- (a) When signs are properly posted as provided in subsection (b) hereof, vehicular traffic shall move only in the direction indicated upon the following streets:
- College Street from Main St. to First St., eastbound
  - First Street from Prospect St. to High St., northbound
  - Second Street from High St. to Prospect St., southbound

**SECTION 3:** All other provisions of the Codified Ordinances of the Village of Mantua, including the remaining sections of Chapter 305.07, shall remain in full force and effect.

**SECTION 4:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 5:** This Ordinance shall take effect and be in full force from and after passage by Council and execution by the Mayor, at the earliest date allowed by law, to preserve the Public health, peace, safety, and welfare within the whole of the Village.
