ORDINANCE 2018-04

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2018
APPROPRIATIONS AND DECLARING AN EMERGENCY.**

WHEREAS, the appropriations in the Road and Bridge Levy Fund #2012 must be increased by \$50,000 in order to fulfill the local match for the High St. Paving and Waterline grant project; and

WHEREAS, the Police Training fund appropriations must be increased by \$1,000 to pay for the Police Chief's training conference and also ammunition for the May range training; and

WHEREAS, the four grant projects in funds 4201, 4202, 4203, and 4204 must have funds appropriated to meet obligations of pass-through payments and local matching shares for these projects.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Mantua, Portage County, Ohio, two thirds or more of the members elected thereto concurring, that:

SECTION 1. Council does hereby authorize the following adjustments to the 2017 Village Appropriations:

This Ordinance is hereby declared to be an emergency measure, necessary to maintain correct accounting practices, to pay the current and imminent financial obligations of the Village and to prevent expenditures from exceeding appropriations, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.
