**ORDINANCE 2018-21**

**AN ORDINANCE REPEALING ORDINANCE 2018-18, REINSTATING ORDINANCE 2017-45 ESTABLISHING ONE-WAY TRAVEL ON SECOND STREET, AND DECLARING AN EMERGENCY.**

**WHEREAS**, by passage of Ordinance 2017-45, this Council converted Second Street from a two-way street to a one-way street southbound; and

**WHEREAS**, subsequent issues relating to mail delivery led this Council to pass Ordinance 2018-18 on March 20<sup>th</sup>, 2018, suspending the operation of 2017-45 and reinstating two-way travel on Second Street until such time as the mail delivery issues could be resolved; and

**WHEREAS**, on April 13<sup>th</sup>, 2018, the Postal Service informed the Village that the mail route would be modified effective April 23<sup>rd</sup>, 2018, thus permitting Second Street to be returned to one-way, as was the original intent of this Council with the passage of Ordinance 2017-45.

**NOW THEREFORE**, be it Ordained by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:

**SECTION 1:** This Council hereby repeals Ordinance 2018-18, passed on March 20, 2018.

**SECTION 2:** Effective immediately, this Council hereby reinstates the operation of all sections of Ordinance 2017-45, establishing one-way travel on Second Street and amending Section 305.07(a) of the Village of Mantua Codified Ordinances.

**SECTION 3:** All other provisions of the Codified Ordinances of the Village of Mantua, including the remaining sections of Chapter 305.07, shall remain in full force and effect.

**SECTION 4:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 5:** This Ordinance is hereby declared an emergency measure, effective immediately in order to reinstate the operation of Ordinance 2017-45 making Second Street one-way southbound at the earliest possible time.
