**ORDINANCE 2019-07**

**AN ORDINANCE REPAYING THE REMAINING BALANCE OF ADVANCES  
PREVIOUSLY MADE FROM THE GENERAL FUND TO THE SEWER OPERATING  
FUND #5201.**

**WHEREAS,** Advances from the General Fund to the Sewer Operating Fund #5201 were made by Resolution 2009-35, as amended by Resolution 2011-28 (\$26,000.04) and Resolution 2010-62, as amended by Resolution 2011-28 (\$31,431.12); and

**WHEREAS,** This Council has established a repayment schedule for these advances in Ordinance 2011-29, which has subsequently been amended by Ordinances 2014-51, 2015-29 and 2017-29; and

**WHEREAS,** this Council has now determined that with the impending loss of the water and wastewater plants, the remaining balance of the repayment scheduled from Sewer Operating Fund #5201 to the General Fund #1000 should now be repaid in full.

**NOW, THEREFORE, BE IT ORDAINED,** by the Council of the Village of Mantua, Portage County, Ohio, a majority or more of the members elected thereto concurring, that:

**SECTION 1.** The remaining balance of \$12,922.29 of the monies advanced to Fund #5201, and scheduled for repayment by Ordinance 2011-29, shall now be repaid in full to the General Fund.

**SECTION 2.** “Exhibit A” to Ordinance 2011-29 is hereby amended so as to be consistent with Section 1 of this Ordinance.

**SECTION 3.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION 4.** This Ordinance shall be in full force and effect after passage by at least a majority of the members elected to the Mantua Village Council at the earliest period allowed by law.
