ORDINANCE 2019-08

AN ORDINANCE APPROVING A COMPETITIVE BID PACKET FOR THE OWNERSHIP, OPERATION & MAINTENANCE OF THE VILLAGE OF MANTUA WATER AND WASTEWATER FACILITIES, AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to Ordinances 2018-56 and 2018-57, passed on October 23, 2018, this Council determined that the Village of Mantua Water Utility and the Village of Mantua Wastewater Utility (“Water and Wastewater Facilities”) should be sold through a competitive bidding process pursuant to law; and

WHEREAS, this Council further authorized Mantua Village Engineer CT Consultants to prepare all necessary bid documents in order to solicit bids for the sale and relinquishment of the ownership and operation of the Water and Wastewater Facilities as provided by law; and

WHEREAS, Section 4 of Ordinances 2018-56 and 2018-57 further required that this Council must approve the bid packet by Ordinance prior to advertisement for bids; and

WHEREAS, this Council now desires to approve a competitive bid packet for the sale and relinquishment of the ownership and operation of the Village of Mantua Water and Wastewater Facilities.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1: The document entitled

REQUEST FOR QUALIFICATIONS & PROPOSAL
OWNERSHIP, OPERATION & MAINTENANCE
of
THE WATER AND WASTEWATER FACILITIES
VILLAGE OF MANTUA, OHIO

as attached hereto as “Exhibit A” and incorporated herein by reference, is hereby approved by this Council.

SECTION 2: The competitive bidding process previously authorized by Ordinances 2018-56 and 2018-57 shall proceed as set forth in those Ordinances.

SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4: This Ordinance is hereby declared to be an emergency measure, in order to expedite the previously authorized competitive bidding process required for the transfer of the Village's Water and Wastewater Facilities to the successful bidder or bidders, and shall take effect

immediately upon the affirmative vote of two-thirds of the members of the Mantua Village Council, and to further ensure the health, safety, and morals of the Village of Mantua.
