ORDINANCE 2019-11

**AN ORDINANCE AMENDING SECTION 135.01 OF THE VILLAGE OF MANTUA
CODIFIED ORDINANCES CONCERNING THE COMPENSATION OF VILLAGE
CLERK-TREASURER.**

(amended)

WHEREAS, The Finance Committee has recommended the schedule of compensation set forth herein for the elective term of the Village Clerk-Treasurer commencing April 1, 2020; and

WHEREAS, The Mantua Village Council has considered this recommendation and wishes to amend Section 135.01 of its Code of Ordinances; and

WHEREAS, Village Council desires to enact this legislation on or before July 16, 2019, in order to comply with Ohio Revised Code 731.13, which requires that the compensation of elected officers for the ensuing term of office be established at a meeting held not later than five days prior to the last day fixed by law for filing as a candidate for such office.

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Mantua, a majority or more of the members elected thereto concurring, that:

SECTION 1: Existing Section 135.01(b) of the Codified Ordinances of the Village of Mantua is hereby repealed.

SECTION 2: Section 135.01(b) of the Codified Ordinances of the Village of Mantua is hereby enacted as follows:

- (b) (1) Effective April 1, 2016, the Village Clerk-Treasurer shall be paid an annual salary of \$44,974.00.
- (2) Effective April 1, 2020, the Village Clerk-Treasurer shall be paid an annual salary of \$44,974.00.
- (3) Effective April 1, 2021, the Village Clerk-Treasurer shall be paid an annual salary of \$44,974.00.
- (4) Effective April 1, 2022, the Village Clerk-Treasurer shall be paid an annual salary of \$45,873.00.
- (5) Effective April 1, 2023, the Village Clerk-Treasurer shall be paid an annual salary of \$46,879.46.

SECTION 3: All other provisions of the Codified Ordinances of the Village of Mantua, including the remaining provisions of Section 135.01, shall remain in full force and effect.

SECTION 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such

formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 5: This Ordinance shall become effective after passage by at least a majority of the members elected to the Mantua Village Council at the earliest period allowed by law.
