RESOLUTION 2019-51**

**A RESOLUTION AUTHORIZING THE CLERK-TREASURER OF THE  
VILLAGE OF MANTUA TO CONDUCT AN INTERNET AUCTION LASTING  
TEN DAYS FOR THE SALE OF A 2007 CHEVROLET IMPALA POLICE  
CRUISER, VIN # 2G1WS55R479380090 WITH A STARTING BID OF \$2000.00,  
AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Village of Mantua has a 2007 Chevrolet Impala Police Cruiser which the Safety Committee has recommended selling; and

**WHEREAS**, the proceeds from a sale of said vehicle will be of use to the Village; and

**WHEREAS**, The Council of the Village of Mantua has passed Resolution 2019-51, pursuant to Ohio Revised Code Section 721.15(D), which provides for the sale of "personal property, including motor vehicles acquired for the use of municipal officers and departments... by internet auction."

**NOW THEREFORE BE RESOLVED** by the Council of the Village of Mantua, two thirds or more of the members elected thereto concurring, that:

**SECTION 1:** It is hereby determined that the 2007 Chevrolet Impala Police Cruiser VIN # 2G1WS55R479380090 is no longer needed for public use by the Village of Mantua.

**SECTION 2:** The Clerk-Treasurer or her designee is hereby authorized to initiate an auction at <http://www.ebay.com>, seeking bids for a 2007 Chevrolet Impala Police Cruiser VIN # 2G1WS55R479380090 owned by the Village. Said auction shall have a duration of ten (10) days, and shall have a starting or reserve price of Two Thousand Dollars (\$2000.00).

**SECTION 3:** The Village shall require a minimum deposit of ten percent (10%) to be paid at the complete in of the auction, and the balance due shall be payable at the time said vehicle is collected by the winning bidder. The Village shall not agree to deliver the vehicle.

**SECTION 4:** The Village shall require that all moneys collected as a result of the auction shall be payable in cash, certified check, or by PayPal.

**SECTION 5:** The net proceeds from the sale of the vehicle shall be deposited in the Police Capital Fund.

**SECTION 6:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

**SECTION 7:** This Resolution is hereby declared an emergency measure, due to the unnecessary use of space and resources in keeping a vehicle no longer needed by the Village, and to initiate the aforementioned internet auction at the earliest possible time, and shall become immediately effective upon its passage by Council and approval by the Mayor, and to further ensure the health, safety, and morals of the Village of Mantua.
