RESOLUTION 2019-58

ADOPTION OF 2020 CALENDAR AND DECLARING AN EMERGENCY.

BE IT RESOLVED, by the Council of the Village of Mantua, two-thirds or more of the members elected thereto concurring, that:

SECTION 1: Regular meetings of the Village of Mantua Council shall be held at six-thirty p.m. eastern standard time or daylight savings time (whichever standard of time is in effect in the Village of Mantua, Ohio at the time of such meeting) in the months of January, February, March, April, May, June, July, August, September, October, November, and December, on the third Tuesday of the month as is set forth in section (2) hereof. The regular meetings shall also be advertised at the permanent principal place of business at the Village Hall. Pursuant to Section 121.03 of the Codified Ordinances of the Village of Mantua, and subject to all relevant provisions of law, regular meetings may be held at another time or location within the Village.

SECTION 2: The Village Council adopts the following calendar, at the following times and places for its 2020 regular meeting schedule:
