ORDINANCE 2026-18

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE
2026 APPROPRIATION AND DECLARING AN EMERGENCY.**

WHEREAS, additional appropriations in the Capital Projects Fund #4901 shall be increased in the total amount of \$30,000.00 for the construction of a new salt storage shed for the Village *to support snow and ice control on public streets*; and

WHEREAS, the Downtown Mantua Revitalization Corporation (DMRC) has also contributed \$25,000.00 to the Village’s Capital Projects Fund #2021; and

WHEREAS, additional appropriations in the Capital Projects Fund #4901 shall be increased in the total amount of \$25,000.00 for the construction of a new salt storage shed for the Village *to support snow and ice control on public streets*; and

WHEREAS, additional appropriations in the State Highway Fund #2021 shall be increased in the total amount of \$11,000.00 for the purchase of road salt; and

WHEREAS, additional appropriations in the Permissive Fund #2102 shall be increased in the total amount of \$11,000.00 for the purchase of road salt.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1. Council does hereby authorize the following adjustments to the 2026 Village of Mantua Appropriations:

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance is hereby declared to be an emergency measure, necessary to maintain correct accounting practices, to pay the current and imminent financial obligations of the Village and to prevent expenditures from exceeding appropriations, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.
